What is this document? This document explains what kind of study we're doing, what your rights are, and what will be done with your data. You should print this page for your records.

Nature of the study. You are invited to participate in a study which involves listening to words and clicking the images they correspond to. Once you finish, we may have also some questions about you and your experience in the study (e.g., age, gender, language background). Your responses will be recorded. Your session should last for up to 20 minutes. You will be given full instructions shortly.

Compensation. You will be paid £10/hr for your participation in this study.

Risks and benefits. There are no known risks to participation in this study. Other than the payment mentioned, there are no tangible benefits to you, however you will be contributing to our knowledge about language.

Confidentiality and use of data. All the information we collect during the course of the research will be processed in accordance with Data Protection Law. In order to safeguard your privacy, we will never share personal information (like your Prolific ID) with anyone outside the research team. Your data will be referred to by a unique participant number rather than by your Prolific ID. Please note that we will temporarily collect your Prolific ID to allow you to withdraw from the study if you wish, however we will never share this information with anyone outside the research team. We will store any personal data using a secure encrypted storage service. The anonymised data collected during this study will be used for research purposes and may be shared with other researchers or with the general public (e.g., we may make it available through the world wide web, or use it in TV or radio broadcasts).

What are my data protection rights? The University of Edinburgh is a Data Controller for the information you provide. You have the right to access information held about you. Your right of access can be exercised in accordance with Data Protection Law. You also have other rights including rights of correction, erasure and objection. If you wish to withdraw after that period, we may not be able to delete your anonymised data from e.g. public repositories of research data, but we will be able to delete all of your personal data from our records.
